Who we are

Transparency International (TI) is a global civil society organization leading the fight against corruption. Through 110 chapters worldwide and an international secretariat in Berlin, we work with partners in government, business and civil society to put effective measures in place to tackle corruption.

Transparency International-Korea (TI-Korea) was established in 1999 through a coalition of civil society organizations. Our purpose is to work together with citizens, government organizations, civil society organizations and businesses to create a transparent society free of corruption. Initiated by TI-Korea, over 250 domestic companies are participating in the **UN Global Compact Korea Network**, a policy initiative pushing businesses to adhere to the 10 universally accepted principles regarding human rights, labor, the environment and anti-corruption.

What is TI-Korea's Business Integrity Forum?

TI-Korea's Business Integrity Forum (BIF) is a network of major national and international companies, convened by TI-Korea, openly committed to high anti-corruption and ethical standards in business practices. Members publicly demonstrate support for the mission and values of TI. BIF allows companies to have well-informed discussions with their peers and experts in an informal setting, as well as access to TI's expertise, events and networks.

Membership Principles

Transparency International-Korea works in partnership with companies that wish to attain the highest standards of integrity and share the vision of the Transparency International movement:

- are committed to implementing the anti-bribery & corruption policy throughout their operations, and have, or will put into place, a monitoring and evaluation process to ensure effective compliance with the company's policy
